NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 14-109

September 29, 2014

Petition of Massachusetts Electric Company and Nantucket Electric Company requesting approval by the Department of Public Utilities of its 2012 and 2013 smart grid pilot program costs and of smart grid customer cost adjustment factors and distribution adjustment factors.

On September 15, 2014, Massachusetts Electric Company and Nantucket Electric Company d/b/a National Grid ("National Grid" or "Company"), filed with the Department of Public Utilities ("Department") a petition for approval of recovery of the Company's 2012 and 2013 costs for its smart grid pilot program ("Pilot"), and for approval of its proposed Smart Grid Customer Cost Adjustment Factors ("SGCCAFs") and Smart Grid Distribution Adjustment Factors ("SGDAFs"). National Grid seeks approval for the recovery of these costs pursuant to St. 2008, c. 169, § 85; <u>Massachusetts Electric Company and Nantucket</u> <u>Electric Company</u>, D.P.U. 11-129 (2012) (approving the Pilot program); and its Tariff for Basic Service, M.D.P.U. No. 1237 and its Smart Grid Adjustment provision, M.D.P.U. No. 1238. This matter has been docketed as D.P.U. 14-109.

In D.P.U 11-129, at 101-102, the Department approved National Grid's proposal to recover customer-facing Pilot costs through its basic service rates and grid-facing Pilot costs from all distribution customers. In this proceeding, the Company seeks to recover \$10,380,641 in customer-facing costs through the SGCCAFs and \$751,130 from grid-facing costs through the SGDAFs. The Company proposes to allocate the SGDAF amount to rate classes using a distribution revenue allocator, which results in the following proposed SGDAFs, effective November 1, 2014:

The Company also proposes to allocate the SGCCAF amount to customer groups using a distribution revenue allocator, which results in the following proposed SGCCAFs, effective November 1, 2014:

Customer Group	SGCCAFs (\$/kWh)
Residential	\$0.00091
Commercial	\$0.00090
Industrial	\$0.00093

If the Department approves the Company's proposal, the monthly bill for a typical National Grid residential basic service customer (<u>i.e.</u>, a customer using 600 kWh of electricity per month) will experience a monthly increase of 58 cents, or 0.6 percent.
